AUTHOR SELF-ARCHIVING POLICY

European Papers – A Journal on Law and Integration aims to offer a real and immediate open access for academic work (see *European Papers* “**Open Access Statement**”). The publication of the results of a scientific research is a highly complex procedure, which imposes to all the subjects involved (Board of Editors and Editorial Committee of *European Papers*, Reviewers and Authors) with particular rigor and accuracy (see *European Papers* “**Code of Ethics**”, adopted in conformity with the [COPE Guidelines](#) and [Core Practices](#), and *European Papers* “**Policy Screening for Plagiarism**”). Furthermore, *European Papers* adopts the following “**Author Self-archiving Policy**”.

The Author(s) **original version** is defined here as the un-refereed Author(s) version of a paper that is considered by the Author(s) to be of sufficient quality to be submitted to *European Papers* for formal peer review. The Author(s) accepts full responsibility for the paper, which may have a version number or date stamp, and content and layout of which is set out by the Author(s).

The **accepted manuscript** is defined here as the final draft author manuscript, as accepted for publication by *European Papers*, including modifications based on referees’ suggestions, before it has undergone copy-editing and proof correction.

Original version of a paper submitted to *European Papers* for formal peer review cannot be uploaded to publicly-available websites, even before the submission.

Only accepted manuscript in pdf format can be uploaded to an institutional and/or centrally organized repository, provided that **public availability is delayed after the end of the double-blind peer-review**.

When uploading an **accepted manuscript** to a repository, Authors should include (e.g. in the first footnote) the following **acknowledgment** as well as a link to *European Papers* website (www.europeanpapers.eu), where the final version of the paper will be published. This will guarantee that the final version of paper is readily available to those accessing the article from public repositories, and means that the article is more likely to be cited correctly.

“This is a pre-copyedited, author-produced version of a paper accepted for publication in *European Papers – A Journal on Law and Integration* (www.europeanpaper.eu) following peer review. The final version of the paper [insert complete information here (see *European Papers Official Citation*)] will be available on-line at: [insert URL that the Author will receive upon request by the EP Managing Editors (submission@europeanpapers.eu) here]”.

Once the paper is published, the **URL of the final authoritative version** on the *European Papers* website must be inserted in the aforementioned acknowledgment.

Any **original or pre-print (pre-copyedited, author-produced) versions** of the accepted manuscript should be **removed by the Author(s) upon publication** of his/her/their paper in *European Papers*. After the publication of the paper, **Authors are not permitted to retain the original or pre-print (pre-copyedited, author-produced copy) version of their accepted manuscript on publicly-available websites.**
